Subject: Summary report of questioning of a person informed of the facts made by:
Amanda Marie KNOX, particulars already recorded in other records.

On 4th November 2007 at 14:45, in the offices of the Flying Squad of the Perugia Police. Before the undersigned officers of the Assistant Deputy Chief GIOBBI Edgardo, Assistant Deputy Chief Marco Chiachiera, Chief Inspector Monica NAPOLEONI and in the presence of the interpreter of English COLANTONE Aida, the person indicated in the subject is present who, in addition to the statements made on the dates of 2nd and 3rd November in these offices, with regards to the circumstances being investigated, states the following:-----

When asked she responds: I know a young man who frequents an Internet Café which is called Internet Point situated in the centre of Perugia in the area of the Cathedral. This young man is Argentine and is called Juve and his number is 320/375812.-----

When asked she responds: Yes, he came to my house at least five times with the last time being 31st October 2007; he also knows Meredith because he met her at the pub while with me.-----

When asked she responds: Juve has never tried it on with me, he has the habit of hugging and touching, even when he's not drunk; however he has a girlfriend and he has always said that he has good principles towards his girlfriend.-----

When asked she responds: Juve is about 1.80 meters tall, slim with a bit of a tummy, dark and curly hair that reaches his neck, dark skin, he usually wears jeans, t-shirt and trainers.-----

When asked she responds: Meredith did not have a close relationship with Juve and when he came to see me at my house Meredith wasn't there. I knew that Meredith didn't like Juve, because of his way of behaving.-----

When asked she responds: The other men that I brought home are a certain Spyros who is about 1.80 meters tall (tel: 3293473230) and who I brought home only once in October and in that occasion he met Meredith without speaking to her, but just saying hello; Daniele from Rome, whose telephone number I don't know. Daniele came to my house twice, the second time he spoke with Meredith saying hello to her.-----

When asked she responds: Pasquale ALESSI also known as Jafar, is the owner of Merlin's; he knew Meredith, who had the intention to go and work for him. Meredith said he was nice and she never said that she had called him. I don't know if Jafar knows where we live.-----

When asked she responds: I know Giorgio the friend of the guys who live downstairs; he often came to the house, also to my house and he knew Meredith with whom he had a friendly relationship. Giorgio danced in the clubs with both me and with Meredith, and also with others. Giorgio is not tall, he's only just taller than me.-----

Amanda KNOX is made aware of the fact that, through delegation of the qualified judicial authority, as a witness, she is bound to secrecy, with the aim of not prejudicing the on-going investigations.-----

This summary record having been read and confirmed is undersigned by all those present.-----
